Mr. Bocchino stated that they are still waiting for the Contract 35 Re-Bid. The Clarifier project issue is temporarily resolved with the temporary seal fix until the manufacturer has a permanent solution.

JoAnn Mondsini advised that there was an issue with the Clarifier Project and it resulted in a seal failing twice, and solids discharging into the Rockaway Valley River, also due to the increased flow during the winter season with only 2 Clarifiers operating. The hotline was called for exceeding the 7 day max discharge of CBOD for the month of December. There is a concern that the other seals could fail. Kleinfelder provided a letter of deficient work to Tomar and the manufacturer demanding they do the repair as quickly as possible. Temporarily, Tomar installed a double clamp seal method while a solution is evaluated. DEP is aware of the situation and Kleinfelder is working quickly to resolve the issue. RVRSA's wastewater discharge is back in compliance. The insurance company has been notified.

JoAnn also stated that they got the engineers met at the Firemen's' Home site. A report from the Home's engineer is anticipated to be submitted to RVRSA shortly.

Lawyer's Report

Mr. Maraziti stated that a closed session was not necessary unless there was further discussion after his report. There were two depositions with sewer experts from Jersey City done last week with respect to the remaining issues left with the trial. Deposition of Tim Bradley will take place next week. Next Thursday, a case management conference is scheduled with Judge Minkowitz in order to plan for a trial in the case. A motion of summary judgement has been filed on the basis of expert reports submitted by JC. There are 8 individual projects in dispute and 4 projects with varying percentages fit the definition according to JC. After Feb 14, we will schedule the trial after we know how many projects we have to dispute. The judge's decision is being disputed by JC as they reserve the right to an appeal.
