Lawyers Report

- Joseph Maraziti gave an update on Jersey City Trial:
 - 1. The trial has been going on for several days on the phase for damages.
 - 2. The current status is that we put in our case through testimony of JoAnn Mondsini and Tim Bradley. Testimony by expert witness for Jersey City, William McConnell and those three witnesses have been cross examined.
 - 3. The defense, Jersey City, is reading into the record, testimonies for depositions of Sandy Thai, Robert Bocchino and the Fletcher Platt. We will then have the expert testimony for Jersey City, Mr. Gaul.
 - 4. This case is about seeking damages for Jersey City to pay for debt service for five projects: They are Contract 35 Rebid II, which is the work on the Boonton interceptor leading up to the Washington Street Crossing, then the work done on preliminary treatment facility, and then the work done on the biosolids facility, the Monroe Street Pump Station that was installed as a result of a damaged washout old Jersey City line under the Rockaway River because of Hurricane Irene, and then the work done because of the collapse of the pipe in the Boonton Park area known as Santaland. These five projects, so far, have calculated to be over \$6,000,000 in unpaid debt services based upon the estimates we submitted. Our claim is that we are entitled to be paid at 100% on the debt service on those projects with exception of the bio biosolid facility that we have provided a credit to Jersey City. Those payments to the IBank will continue for a period of many, many years and we asked the judge determine that Jersey City pay for that as well.
 - 5. We were prepared to put in testimony on the cost of the clarifier, as well as the description of what the final clarifier work is, however, Jersey City objected to that, and the judge agreed with the objection because we haven't yet sent the bill to Jersey City for the debt service payment for that project. Once we go to permanent financing, will have to be subject to another proceeding, if in fact, Jersey City refuses to pay for that.
 - 6. All the testimony has gone in and Jersey City has made a motion to dismiss our case on the basis that we haven't proved the damages. There is an issue on what the definition of the cost is based on the judges ruling in October 2018 where he defined the term lowest cost. We have maintained that lowest cost means looking at the full life cycle cost of the project, not just the initial upfront cost.
 - 7. There will be a continuation of the trial next Friday, April 16th, to continue the testimony of Jersey City, cross examination, then a rebuttal case.
 - 8. Don Farrell has been at this trial the entire process on the ZOOM.
 - 9. This is all a matter of public record, any questions or concerns can be addressed in

a closed session if needed.
