

RESOLUTION RESCINDING AWARD OF  
ALCOHOL AND DRUG TESTING SERVICES CONTRACT TO CONNER STRONG  
AND AWARDING CONTRACT FOR ALCOHOL AND DRUG TESTING SERVICES TO  
VALLEY HEALTH MEDICAL GROUP

**WHEREAS**, Alcohol and Drug Testing Services are mandatory to companies which engage Commercial Drivers Licenses to carry out truck driving operations, on a random basis; and

**WHEREAS**, the RVRSA has adopted a zero tolerance policy on alcohol and drug substance abuse, which will require alcohol and drug on an as needed basis; and

**WHEREAS**, at the RVRSA reorganization meeting of February 11<sup>th</sup> 2010, RVRSA, by Resolution 10-023, inadvertently awarded a contract for the performance of these services to Conner Strong Risk Control, the prior contractor of the New Jersey Utility Joint Insurance Fund. This award was in error, as Connor Strong no longer provides such testing as a subcontractor to the NJ Utility Joint Insurance Fund; and

**WHEREAS**, the RVRSA is desirous of awarding a contract to the firm of Valley Health Medical Group, the firm that currently provides such testing as a subcontractor to the NJ Utility Joint Insurance Fund, for the schedule of fees as provided in the attached Agreement, and the firm of Valley Health Medical Group possesses the requisite proficiency and expertise required to conduct such alcohol and drug testing; and

**WHEREAS**, B. K. Sandy Thai, CFO certifies that there sufficient funds allocated under the 2010 RVRSA's adopted budget at line item 532.4.

**NOW, THEREFORE, BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority as follows:

1. That the contract awarded to Conner Strong for Alcohol and Drug Testing Services is hereby rescinded.
2. That a contract for Alcohol and Drug Testing is henceforth awarded to Valley Health Medical Group (VHMG) of 15 Essex Road, Suite 504, Paramus, N. J. 07652 and the Executive Director is authorized and directed to execute a Contract for the provision of Alcohol and Drug Testing Services in the form reviewed and approved by the Authority and attached hereto, subject to such minor modifications not affecting the substance thereof as may be required.
3. This Resolution shall take effect as provided by law.
