RESOLUTION ADOPTING PERMIT MODIFICATION
REGARDING TEMPORARY FLOW INCREASE TO INDUSTRIAL
SEWER CONNECTION PERMIT OF WHITLOCK PACKAGING

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter "the Authority") is authorized by the Sewerage Authorities Law [N.J.S.A. 40:14A-7(11)] to make and enforce rules and regulations for the management and regulation of its business and affairs and/or the use, maintenance, and operation of the sewerage system and any other of its properties and to amend the same; and

WHEREAS, the Authority is a Delegated Local Agency of the New Jersey Department of Environmental Protection and administers an industrial pretreatment program within the service area of the Authority; and

WHEREAS, by Resolution Number 11-035, adopted at a regular meeting of the Authority held on April 14, 2011, the Rockaway Valley Regional Sewerage Authority ("RVRSA") issued a temporary additional 50,000 GPD (gallon per day) increase in flow from May 1, 2011 to September 30, 2011, to the Industrial Sewer Connection Permit issued to Whitlock Packaging, 92 North Main Street, Wharton, New Jersey; and

WHEREAS, in accordance with N.J.A.C. 7:14A and by authority of the Water Pollution Control Act at N.J.S.A. 58:10A-1 et seq., the RVRSA proposed a modification to the permit issued to Whitlock Packaging to incorporate into the industrial users' permit an increase in flow, an increase in the BOD load, and institution of daily BOD sampling of the Whitlock effluent, relevant to the wastewater discharge into and treatment by the RVRSA; and

WHEREAS, in accordance with requirements promulgated at N.J.A.C. 7:14A-19.10, public notice was published in the May 11, 2011 and written notice provided to the industrial discharger, and an opportunity for public comment provided prior to adoption of a modification to an Industrial Pretreatment Permit; and

WHEREAS, comments were submitted on behalf of Whitlock prior to the close of the public comment period relevant to the adoption of such modification to its Industrial Pretreatment Permit, and a Response to Comments document responding to all relevant comments submitted was prepared by the Authority in accord with N.J.A.C. 7:14A-15.16, and the Response to Comments document is attached hereto and made a part hereof; and

WHEREAS, the Authority finds that it is necessary and appropriate to allow for such increase in flow, increase in the BOD load, and imposition of daily BOD sampling, and to condition such flow upon the payment of all fees associated with the increased allocation of flow.

NOW, THEREFORE, BE IT RESOLVED, by the Rockaway Valley Regional Sewerage Authority as follows:

1. A permit modification is hereby adopted authorizing a temporary additional 50,000 GPD (gallon per day) increase in flow, increase in BOD load, and imposition of daily BOD sampling, from May 1, 2011 to September 30, 2011, to Whitlock Packaging, 92 North Main Street, Wharton, New Jersey, subject to payment of all fees associated with such flow.

2. The Executive Director is hereby authorized and directed to forward notice of this permit action, and a copy of the final permit modification and Response to Comments document, to Whitlock Packaging allowing a temporary additional 50,000 GPD (gallon per day) increase in flow from May 1, 2011 to September 30, 2011.
