### **Executive Director's Report**

Report- JoAnn Mondsini reported that we did have a minor chemical spill last Friday. Everyone acted as they were trained. The chemical supplier sent a cleanup crew, a HazMat Team, to cleanup. The spill did not leave the spill containment area; it fell in the containment area in the filter building. Everything worked the way it was designed to work, so there were no injuries. There were 14 55-gallon drums outside, which equaled approximately 750 gallons of Alum Sulfite mixed with a small amount of Ammonia Sulfite. It was a mix-up at the fill point where one or more people failed to read the words correctly on the fill box. Those two chemicals, when mixed together, are compatible, and they just form a double salt solution, so there was no risk of fire or explosion. We had an after-incident meeting, and there are a few steps we will take to December 12, 2024 Minutes

make it more clear to the people doing the filling so that they choose the correct fill head for the chemical they are filling. We had Morris County Hazmat, Parsippany Hazmat, Parsippany Fire Department, Parsippany Police Department and the ambulance all here, which is a standard rollout. DEP was also notified.
