AWARDING CONTRACT NO. 39 - JERSEY CITY TRUNK SEWER REHABILITATION 2014 TO NATIONAL WATER MAIN CLEANING COMPANY SUBJECT TO APPROVAL BY THE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter "the Authority") issued a Notice to Bidders seeking sealed competitive bids for Contract 39 – Jersey City Trunk Sewer Rehabilitation 2014 (State Project No. S340821-06); and

WHEREAS, the Authority received one sealed competitive bid on July 29, 2015 at 11:00 a.m.; and

WHEREAS, the aforementioned bid submitted by National Water Main Cleaning Company, having a business address of 1806 Newark Turnpike, Kearny, New Jersey ("National Water Main") was in the amount of \$518,015.00; and

WHEREAS, the bid submitted by National Water Main was reviewed by the Authority's staff, Hatch Mott MacDonald and the Authority's legal counsel, Maraziti Falcon L.LP.; and

WHEREAS, after the aforementioned review and in accordance with its letter, dated July 31, 2015, Hatch Mott MacDonald recommends that the Authority award Contract 39 – Jersey City Trunk Sewer Rehabilitation 2014 (State Project No. S340821-06) to National Water Main, subject to a favorable legal opinion from the firm of Maraziti Falcon LLP; and

WHEREAS, after the aforementioned review and in accordance with its memorandum opinion, dated August 3, 2015, the firm of Maraziti Falcon, L.L.P. opines that the bid of National Water Main does not contain any material defects; and

WHEREAS, funds to finance Contract 39 - Jersey City Trunk Sewer Rehabilitation

2014 (State Project No. S340821-06), through the New Jersey Environmental Infrastructure

Trust, have been made available to the Authority.

NOW THEREFORE BE IT RESOLVED by the Rockaway Valley Regional Sewerage

Authority in the County of Morris and the State of New Jersey on this 13th day of August, 2015

as follows:

Contract 39 - Jersey City Trunk Sewer Rehabilitation 2014 is awarded to 1.

National Water Main Cleaning Company, having a business address of 1806 Newark Turnpike, Kearny, New Jersey, as the lowest responsible and responsive bidder in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et

seq., subject to approval of award by the New Jersey Department of

Environmental Protection.

2. The Executive Director, staff and consultants are authorized to take all

appropriate actions to effectuate the terms of this Resolution and to take measures to ensure that all appropriate documents, as required by Contract 39 – Jersey City Trunk Sewer Rehabilitation 2014, are provided by the Contractor prior to the

issuance of a Notice to Proceed

3. This Resolution shall take effect immediately.
