

RESOLUTION AWARDING CONTRACT FOR
OCCUPATIONAL HEALTH SERVICES TO
CHILTON OCCUPATIONAL HEALTH

WHEREAS, there exists a need for the Rockaway Valley Regional Sewerage Authority to engage medical services for the provision of vaccines and occupational health services to its employees and candidates for employment on an as needed basis; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40:11-1 et seq.) authorizes contracts for the provision of "Professional Services" which may be awarded without public advertising and competitive bidding therefore, provided a brief notice of the award is published and that the resolution and contract are kept on file and available for public inspection; and

WHEREAS, the foregoing services are professional services as defined in the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) which are permitted to be contracted without public bidding as set forth in N.J.S.A. 40A:11-5(1)(a); and

WHEREAS, the Authority received a Proposal from Chilton Occupational Health for the provision of medical services dated January 6, 2016, attached hereto and made a part hereof; and

WHEREAS, such Proposal was reviewed and evaluated by RVRSA staff; and

WHEREAS, pursuant to N.J.A.C. 5:30- 5.4, B. K. Sandy Thai, Controller for the RVRSA, as the Chief Financial Officer for the RVRSA certifies as to the monies being used to fund these professional services are available in the 2016 Year Budget of the RVRSA at line item 01-501-120.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

1. The Rockaway Valley Regional Sewerage Authority recognizes that Chilton Occupational Health has an established reputation in the field of occupational medicine, and that they possess the specialized abilities and resources to provide the expert professional services necessary to meet the Authority's needs.

2. The Executive Director of the Rockaway Valley Regional Sewerage Authority is hereby authorized and directed to execute an agreement for the provision of professional services between the Rockaway Valley Regional Sewerage Authority and Chilton Occupational Health,

having a business address of 242 West Parkway, Pompton Plains, New Jersey, 07444, for the performance of the services outlined in the attached Proposal dated January 6, 2016.

3. Notice of Contract Award shall be published in the Daily Record as required by law within 10 days of its passage.


