## Resolution 16-0129

## RESOLUTION TERMINATING THE INDUSTRIAL SEWER CONNECTION PERMIT OF CLEANWAY HAND CAR WASH

WHEREAS, the Rockaway Valley Regional Sewerage Authority is a delegated local agency pursuant to the Water Pollution Control Act, N.J.S.A. 58:10A-1 et seq., N.J.S.A 58:11-49 et seq. and regulations promulgated pursuant thereto at N.J.A.C. 7:14A-19, and has an established Industrial Pretreatment Program to allow for and regulate the discharge of industrial effluent via a permit program pursuant to RVRSA's "Service Rules, Regulations Concerning Industrial Users: Industrial Sewer Permits, Regulations concerning Sewer Use: Pretreatment Regulation" ("RVRSA's Rules and Regulations"); and

WHEREAS, RVRSA has determined that Cleanway Hand Car Wash is not subject to Categorical Pretreatment Standards under 40 CFR 403.6 and 40 CFR Chapter I, Subchapter N, has ceased to meet the criteria under which an individual Significant Indirect User (SIU) permit is required pursuant to the definition of Significant Indirect User under N.J.A.C. 7:14A-1.2 and criteria established at N.J.A.C. 7:14A-2 et seq., and has no reasonable potential for adversely affecting the RVRSA's operation or for violating any Federal, State, or local pretreatment standard or requirement; and

WHEREAS, in accordance with 40 CFR 403.8(f)(6), and N.J.A.C. 7:14A-1 et seq., RVRSA has determined that, in accordance with federal, state and local laws, an Industrial Sewer Connection Permit is not required for Cleanway Hand Car Wash to continue operations and discharge wastewater to the RVRSA, and as such, it is appropriate to terminate the Industrial Sewer Connection Permit of Cleanway Hand Car Wash; and

**WHEREAS**, public notice was published on October 22, 2016 in the Daily Record and a thirty (30) day public comment provided, in accordance with N.J.A.C. 7:14A-19(e), which comment period expired on November 22, 2016. No comments or requests for a hearing were received.

**NOW, THEREFORE, BE IT RESOLVED BY** the Rockaway Valley Regional Sewerage Authority that it hereby terminates the Industrial Sewer Connection Permit issued to Cleanway Hand Car Wash.
