RESOLUTION AUTHORIZING EXECUTION OF SLUDGE DISPOSAL
INTERLOCAL SERVICES AGREEMENT

WHEREAS, the Rockaway Valley Regional Sewerage Authority (RVRSA) is authorized pursuant to the Interlocal Services Act, N.J.S.A. 40:8A-1 et. seq., to enter into a contract with any other local unit for the provision of any service which that local unit is empowered to render within its own jurisdiction; and

WHEREAS Passaic Valley Sewerage Commission (PVSC) is a local unit empowered to render sludge disposal services and has the capacity for additional sludge treatment and disposal; and

WHEREAS, the RVRSA desires to have the sludge from the RVRSA treatment plant treated and disposed of by PVSC; and

WHEREAS, PVSC is willing to accept, treat and dispose of RVRSA's sludge; and

WHEREAS, RVRSA wishes to execute a sludge disposal interlocal services agreement with PVSC pursuant to the terms set forth in the attached Interlocal Agreement, Sludge Disposal Contract dated September 18, 2017; and

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority, as follows:

1. The Executor Director is authorized and directed to execute an Agreement substantially in the form annexed hereto subject to such modifications as may be negotiated between the parties which do not modify the terms thereof in any significant respect.

The execution of the Agreement will enable you to discharge only the waste specified in the Application submitted to PVSC and referenced above as the subject of this approval. If applicable, you will also find a Consent of Generator form. This document must be signed by a duly authorized representative of the generator of the waste. Please note that the rate **will be \$45.00 per 1,000 gallons.**

Upon execution by PVSC, an executed Agreement will be forwarded to you for your records. If this is for a new application, upon submission of the PVSC Agreement a source code will be added to our current approved source list.
