

RESOLUTION # 17-141

RESOLUTION AUTHORIZING EXECUTION
OF CONTRACT FOR
SLUDGE HAULING SERVICES

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter "RVRSA") desires to enter into a contract for the provision of sludge hauling services to transport residual resulting from the wastewater treatment process off-site for ultimate disposal; and

WHEREAS, the RVRSA advertised for bid proposals to provide sludge hauling services to the RVRSA, according to bid specifications, for a twelve (12) month period with an option to renew such contract for an additional twelve (12) month period at the sole discretion of the Authority; and

WHEREAS, the bid of R-D Trucking, Inc., being the apparent lowest, was reviewed by the Authority's Staff to determine compliance with the technical specifications; and

WHEREAS, by memorandum dated December 06, 2017, Diane Alexander, Esq. of Maraziti, Falcon, LLC has determined that the bid submitted by the apparent low bidder R-D Trucking Inc., has met the legal requirements set forth in the bid specifications; and

WHEREAS, based upon its review of the bid price proposed, the Authority has determined that it would be in the best interests of the Authority to award the bid to R-D Trucking, Inc., for a term of twelve (12) months at \$0.0265 per gallon and to extend the contract for an additional twelve (12) month period at \$0.0265 per gallon applicable to months 13 to 24, subject to the availability of funding therefore; and

WHEREAS, the CFO has certified that sufficient funds are available in line item 01-506-032 for months 1 to 12.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

1. The bid for Sludge Hauling Services from R-D Trucking, Inc., 1874 Route 23 North, West Milford, NJ 07480 be accepted in accordance with the bid specifications and the bid proposal which is on file in the offices of RVRSA in the amount of:
\$0.0265/gallon for months 1 to 12
\$0.0265/gallon for months 13 to 24
2. The Executive Director is authorized and directed to execute a contract for supplying Sludge Hauling Services to R-D Trucking, Inc., subject to the availability of financing for months 13 to 24, in accordance with the proposal for the same submitted November 21, 2017.
3. A copy of the resolution and contract shall be kept available for public inspection at the RVRSA office at the Administration Building, 99 Green Bank Road, Parsippany, and New Jersey.
4. This resolution shall take effect as provided by law.
