RESOLUTION AUTHORIZING EXECUTION
OF CONTRACT FOR
SODIUM HYPOCHLORITE SOLUTION (15%)

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter "RVRSA") desires to purchase SODIUM HYPOCHLORITE SOLUTION (15%); and

WHEREAS, the RVRSA advertised for bid proposals to supply the RVRSA with Sodium Hypochlorite Solution (15%), according to bid specifications; and

WHEREAS, the bid of Univar USA, Inc., located at 532 East Emaus Street, Middletown, PA, 17057, being the apparent lowest, was reviewed by the Authority's Staff to determine compliance with the technical specifications; and

WHEREAS, by memorandum dated December 06, 2017, Diane Alexander, Esq. of Maraziti, Falcon LLC has determined that the bid submitted by the apparent low bidder Univar USA, Inc., has met the legal requirements set forth in the bid specifications; and

WHEREAS, based upon its review of the bid price proposed, the Authority has determined that it would be in the best interests of the Authority to award the bid to Univar USA, Inc., for a term of twelve (12) months at \$0.734 per gallon and to extend the contract for an additional twelve (12) month period at \$0.764 per gallon applicable to months 13 to 24, subject to the availability of funds therefore; and

WHEREAS, the CFO has certified that sufficient funds are available in line item 01-506-033 for months 1 to 12.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

1. The bid for Sodium Hypochlorite Solution (15%) from Univar USA, Inc., located at 532 East Emaus Street, Middletown, PA 17057, be accepted in accordance with the bid specifications and the bid proposal which is on file in the offices of RVRSA in the amount of:

\$0.734/gallon for months 1 to 12

\$0.764/gallon for months 13 to 24

2. The Executive Director is authorized and directed to execute a contract for supplying Sodium Hypochlorite Solution (15%) to Univar USA, Inc., subject to the availability of funds for months 13 to 24, in accordance with the bid proposal for the same submitted November 21, 2017.
3. A copy of the resolution and contract shall be kept available for public inspection at the RVRSA office at the Administration Building, 99 Green Bank Road, Parsippany, and New Jersey.
4. This resolution shall take effect as provided by law.


