

RESOLUTION 18-066

**RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR
EQUIPMENT REPAIR OF RVRSA GENERATORS**

WHEREAS, the Rockaway Valley Regional Sewerage Authority (RVRSA) owns and operates generators utilized to convey wastewater for treatment and to achieve compliance with the terms and conditions of its wastewater discharge permit; and

WHEREAS, emergency repairs, that cannot be anticipated in scope or time, are periodically needed to this equipment; and

WHEREAS, the RVRSA solicited two competitive quotes, competitive quotes attached, for hourly rates for annual and emergency repair services; and

WHEREAS, the Authority desires to award a contract for the performance of such repair work to ASCO Power Services, Inc., located at 160 Park Avenue, Florham Park, New Jersey 07932, in an amount not to exceed \$6,000.00; and

WHEREAS, funds are available in the line item 01-503-240.

NOW THEREFORE, BE IT RESOLVED that the Rockaway Valley Regional Sewerage Authority as follows:

1. The Authority hereby authorizes the Executive Director to enter into a contract with ASCO Power Services, Inc., located at 160 Park Avenue, Florham Park, New Jersey 07932 to affect emergency repairs to the RVRSA generators, as the need arises, in an amount not to exceed \$6,000.00 without the prior authorization of the RVRSA.

2. The Executive Director shall cause a copy of the within Resolution to be published in an official newspaper of the Authority.

3. This Resolution shall take effect immediately.



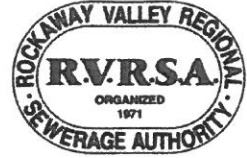
