RESOLUTION AUTHORIZING AMENDMENT TO CONTRACT WITH GEAR 3 TECHNOLOGIES, FOR THE PROCUREMENT OF COMPUTER IT SERVICES

WHEREAS, the Rockaway Valley Regional Sewerage Authority ("RVRSA") requires computer IT services and the provision of support and maintenance of the same; and

WHEREAS, by Resolution 17-144, adopted December 14, 2017, the Rockaway Valley Regional Sewerage Authority (the "Authority") authorized Gear 3 Technologies, having an office at 31 Airpark Road, Princeton, New Jersey ("Gear 3"), to undertake such services as set forth in Gear 3's proposal dated December 5, 2017, in an amount not to exceed \$45,000.00 without prior authorization; and

WHEREAS, the Authority requires additional funds for continued managed services, email and tablet management from Gear 3 Technologies, for Computer IT services; and

WHEREAS, the RVRSA desires to authorize Gear 3 for continued support/maintenance of proprietary computer hardware and software only, and not to acquire or update non-proprietary software, in an amount not to exceed \$10,000.00 without prior authorization; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-5(1) (dd), a contract may be awarded without public advertising for bids and bidding for the provision or performance of goods or services for the support or maintenance of proprietary computer hardware and software, provided that this exemption shall not be utilized to acquire or upgrade non-proprietary hardware or to acquire or update non-proprietary software; and

WHEREAS, funds are available for these purposes at line item 01-501-025; and

NOW, THEREFORE, BE IT RESOLVED the Rockaway Valley Regional Sewerage Authority as follows:

- 1. The Executive Director of the Rockaway Valley Regional Sewerage Authority is hereby authorized and directed to execute an amendment to the existing contract for Computer IT Services, with the firm of Gear 3 Technologies, having an office at 31 Airpark Road, Princeton, New Jersey, in an amount not to exceed \$10,000.00 without prior authorization, for a new total contract amount of \$55,000.00, and conditioned upon the submission by Gear 3 Technologies of its New Jersey Business Registration Certificate and Business Entity Disclosure Certification.
- 2. A copy of this Resolution shall be published in accordance with N.J.S.A. 40A:11-5(a)(i).
- 3. This Resolution shall take effect as provided by law.
