RESOLUTION AUTHORIZING THE EXECUTION OF A CONTRACT WITH UNIVERSAL BUSINESS AUTOMATION, INC., FOR THE PROCUREMENT OF COMPUTER IT SERVICES FOR RVRSA PERMIT SYSTEM

WHEREAS, under the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(dd), a contract may be awarded without public advertising for bids and bidding for the provision or performance of goods or services for the support or maintenance of proprietary computer hardware and software, provided that this exemption shall not be utilized to acquire or upgrade non-proprietary hardware or to acquire or update non-proprietary software; and

WHEREAS, funds are available therefore in 01-501-025.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority, as follows:

1. The Executive Director is authorized and directed to enter into a contract with Universal Business Automation, Inc., having a business address of 170 Changebridge Road, Unit D-3, Montville, New Jersey, in the form attached hereto for the provision of such services, and at the rates set forth therein, in an amount not to exceed \$10,000.00.
