RESOLUTION AUTHORIZING CLOSED SESSION PURSUANT TO THE OPEN PUBLIC MEETINGS LAW

- 1. The Authority shall also adjourn to executive session in accordance with N.J.S.A. 10:4-12(b)(7), being the Open Public Meetings Law, in order to discuss issues involving threatened or pending litigation and matters relating to attorney-client privileged communications relevant to *JoAnn Mondsini v. Local Finance Board, Docket Nos. A-4482-16T4, A-4504-16T4* (decided March 5, 2019).
- 4. The Minutes of the portion of the Closed Session relating to threatened or pending litigation and attorney-client communications shall be available to the public as soon as the matters under discussion are no longer of a confidential or sensitive nature.
- 5. Further, the Authority shall also adjourn to executive session in accordance with N.J.S.A. 10:4-12(b)(7), being the Open Public Meetings Act, in order to discuss pending litigation
