RESOLUTION TO AUTHORIZE THE EXECUTION OF CHANGE ORDER 3 TO CONTRACT NUMBER 40, FINAL CLARIFIERS REPAIR PROJECT

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter the "Authority") entered into Contract 40 for the Final Clarifiers Repair Project with Tomar Construction Services, Inc., 6 Spruce Meadows Drive, Monroe, New Jersey (hereinafter the "Contractor"); and

WHEREAS, certain additions to the contract tasks are required to be made, namely, Perimeter site lighting at the Final Clarifiers and Chlorine Contact Tank (CCT), as more specifically set forth in the attached correspondence, dated April 7, 2020 from Colin Ferguson, P.E., Principal Engineer, (Kleinfelder) to the Authority's Manager of Engineering, Robert Bocchino, P.E.; and

WHEREAS, the changes referred to in the above referenced correspondence are formalized in the Contract Change Order No. 3, dated April 9, 2020, and reflect a total increase in contract value of \$11,228.61 or approximately 0.20% of the original contract award as follows, and no increase to the contract time of 637 days; and
