**RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH
ATLANTIC CHILTON MEDICAL FOR OCCUPATIONAL MEDICAL SERVICES FOR
THE ROCKAWAY VALLEY REGIONAL SEWERAGE AUTHORITY**

WHEREAS, the Rockaway Valley Regional Sewerage Authority contracted with Atlantic Chilton Medical for Occupational Medical Services; and

WHEREAS, by Resolution 19-118, adopted on December 12, 2019, the Authority appointed Atlantic Chilton Medical to provide occupational medical services in an amount not to exceed \$2,100.00 for FY 2020; and

WHEREAS, the Authority is desirous of increasing the contract value by an additional \$1,000.00, which is needed to provide continued occupational medical services, due to an increase in need for new employment physicals and return to duty evaluations, resulting in a new total contract amount not to exceed \$3,100.00, in accordance with rates stated in the Occupational Health Pricing Agreement, valid through December 31, 2020, attached hereto and made a part hereof; and

WHEREAS, funds are available in the 2020 budget line 01-501-120; and

WHEREAS, the services to be rendered are to be performed by persons authorized by law to practice a recognized profession within the definition of a professional service pursuant to N.J.S.A. 40A:11-5.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority, as follows:

1. The Rockaway Valley Regional Sewerage Authority does hereby authorize an Amendment to the Contract between the RVRSA and Atlantic Chilton Medical to increase the contract amount, without the need for further authorization of the Authority, to an amount not to exceed \$3,100.00.
2. Notice of the nature, duration and amount of the contract shall be published once in the newspaper of general circulation and a copy of this resolution and the agreement shall be on file and available for public inspection in the Office of the RVRSA.
3. This award is subject to the submission of a New Jersey Business Registration Certificate; Certificate of Employee Information Report; proof of professional liability insurance; all documents required by N.J.S.A. 19:44A-20.4 et seq., and any other document required by law to be placed on file with this Resolution.
4. This Resolution shall take effect immediately.
