RESOLUTION AUTHORIZING APPLICATION FOR A LOAN FROM THE NEW JERSEY I-BANK FOR PHASE 1 – EMERGENCY GENERATORS AND SWITCHGEAR REPLACEMENT PROJECT

WHEREAS, the Rockaway Valley Regional Sewerage Authority ("Authority") is desirous of replacing its Emergency Generators and Main Switchgear Facilities ("Phase 1 – Emergency Generators and Main Switchgear Replacement Project – Contract 44") and accordingly intends to file an application with the New Jersey Department of Environmental Protection and the New Jersey I-Bank for a loan in an amount of \$8,000,000 for Phase 1 – Emergency Generators and Main Switchgear Project – Contract 44; and

WHEREAS, RVRSA's Engineer's Five-Year Planning Report, dated December 2018, recommended the planning, design, and construction of the first of three phases of improvements to the WWTP electrical distribution system; and

WHEREAS, RVRSA's Evaluation of Emergency Generators, Main Substation & Unit Substation report, by ELECSYS Engineering Group, dated October 2019, recommended Construction Phases, Budgets & Durations for the replacement of the Emergency Generators, Main Substation and Unit Substations and provided a construction estimate for Phase 1 – Emergency Generators and Main Switchgear of \$5.7 Million dollars; and

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

1. The Executive Director is authorized and directed to act as the Authorized Representative of the Rockaway Valley Regional Sewerage Authority in all matters relating to Phase 1 – Emergency Generators and Main Switchgear
