**RESOLUTION TO AUTHORIZE THE EXECUTION OF CHANGE ORDER 2 TO
CONTRACT NUMBER 41, PHOSPHORUS REMOVAL AND FILTRATION
FACILITIES PROJECT**

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter the “Authority”) entered into Contract 41 for the Phosphorus Removal and Filtration Facilities Project with Coppola Services, Inc., 28 Executive Parkway, Ringwood, New Jersey (hereinafter the “Contractor”); and

WHEREAS, certain additions to the contract tasks are required to be made. Upon review of the location of an existing electrical conduit duct bank above the existing chemical feed pipes and a recent materials cost increase, a change in the Scope of Work is needed for the installation of a temporary 2-inch hypochlorite line and additional funds are needed to purchase piping, as more specifically set forth in the Contract Modification Proposal and Acceptance Form, dated October 08, 2021, by Nancy Catherine Wohlleb, P.E., (Mott MacDonald); and

WHEREAS, the changes referred to in the above referenced correspondence are reflect a total increase in contract value of \$28,486.08 or approximately 0.26% of the original contract award as follows; and

WHEREAS, the Authority has reviewed the Contract Change Order attached hereto and made a part hereof, and is satisfied that it meets the requirements of N.J.A.C. 5:30-11.3, and

WHEREAS, funds are available therefore from line item EIT 41.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

1. Subject to receipt of New Jersey Department of Environmental Protection approval, the Authority hereby approves Change Order No. 2 in the amount of \$28,486.08.
2. Upon receipt of New Jersey Department of Environmental Protection approval, the Executive Director is hereby authorized and directed to execute a Contract Change Order substantially in the form as that attached hereto, in the foregoing amount.

3. This Resolution shall take effect as provided by law.
