RESOLUTION TO AUTHORIZE THE EXECUTION OF CHANGE ORDER 3 TO CONTRACT NUMBER 41, PHOSPHORUS REMOVAL AND FILTRATION FACILITIES PROJECT

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter the "Authority") entered into Contract 41 for the Phosphorus Removal and Filtration Facilities Project with Coppola Services, Inc., 28 Executive Parkway, Ringwood, New Jersey (hereinafter the "Contractor"); and

WHEREAS, certain additions to the contract tasks are required to be made. Upon review of the location of an existing bisulfite feed, a change in the Scope of Work is needed for the relocation of the bisulfite feed line, and connection to the existing bisulfite feed system, as more specifically set forth in the Contract Modification Proposal and Acceptance Form, dated October 19, 2021, by Nancy Catherine Wohlleb, P.E., (Mott MacDonald); and

WHEREAS, the changes referred to in the above referenced correspondence reflect a total increase in contract value of \$20,638.90 or approximately 0.19% of the original contract award as follows; and

- 2. Upon receipt of New Jersey Department of Environmental Protection approval, the Executive Director is hereby authorized and directed to execute a Contract Change Order substantially in the form as that attached hereto, in the foregoing amount.
 - 3. This Resolution shall take effect as provided by law.
