## Resolution 21-132

## RESOLUTION AWARDING CONTRACT TO ALS GROUP USA CORP. DBA ALS ENVIRONMENTAL IN RESPONSE TO BID SPECIFICATIONS FOR LABORATORY SERVICES

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter "the Authority") issued a Notice to Bidders seeking sealed competitive bids for Laboratory Services; and

WHEREAS, the Authority received four sealed competitive bids on November 9, 2021 from APL Environmental, Eurofins, ALS Environmental and Garden State Laboratory Services, Inc.; and

WHEREAS, the bid submitted by the apparent lowest bidder, ALS Environmental, was reviewed by the Authority's staff and the Authority's legal counsel, and

WHEREAS, based upon the aforementioned review it has been determined that the bid submitted by the apparent low bidder complies with the bid specifications in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, based upon the respective bid prices proposed for a twelve (12) month and a twenty-four (24) month period, Authority Staff recommend that it would be in the best interests of the Authority to award the bid to ALS Environmental, for a twenty-four (24) month period for laboratory services, provided that sufficient funding is available for months thirteen (13) through twenty-four (24); and

**WHEREAS**, the RVRSA has sufficient funds available at line items 01-505-020 and 01-503-120 for these purposes.

**NOW THEREFORE BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority on this 9th day of December, 2021 as follows:

- 1. The bid submitted by ALS Group USA Corp. DBA ALS Environmental of 10450 Stancliff Road, Suite 210, Houston, TX 77099, is hereby accepted in accordance with the bid specifications and the bid proposal which is on file in the offices of RVRSA in the amount of \$39,939.00 per year for a term of twenty-four (24) months, provided that sufficient funding is available for months thirteen (13) through twenty-four (24).
- 2. The Executive Director is authorized and directed to execute a twenty-four (24) month contract for supplying laboratory services to ALS Environmental, in accordance with the bid for the same submitted November 9, 2021, subject to the availability of funds for months thirteen (13) through twenty-four (24).
- 3. A copy of the resolution and contract shall be kept available for public inspection at the RVRSA office at the Administration Building, 99 Green Bank Road, Parsippany, and New Jersey.
