## RESOLUTION TO AUTHORIZE THE EXECUTION OF CHANGE ORDER 4 TO CONTRACT NUMBER 41, PHOSPHORUS REMOVAL AND FILTRATION FACILITIES PROJECT

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter the "Authority") entered into Contract 41 for the Phosphorus Removal and Filtration Facilities Project with Coppola Services, Inc., 28 Executive Parkway, Ringwood, New Jersey (hereinafter the "Contractor"); and

WHEREAS, an addition to the contract tasks is required to be made. During the shop drawing review for the new disc filter equipment, it was determined that the proposed disc filter equipment would need to be raised in order to achieve the specified equipment performance, as more specifically set forth in letter dated November 3, 2021 by Nancy Wohlleb, P.E., Mott MacDonald and Contract Modification Proposal and Acceptance Form CM-004, by Nancy Catherine Wohlleb, P.E., (Mott MacDonald); and

WHEREAS, the change referred to in the above referenced correspondence reflect a total increase in contract value of \$3,992.40 or approximately 0.037% of the original contract award as follows; and
