RESOLUTION AUTHORIZING EMERGENCY PROCUREMENT OF ODOR CONTROL SERVICES IN CONNECTION WITH HIGH FLOW UNNAMED STORM EVENT AND CLEANING OF OXIDATION DITCH #3

WHEREAS, on April 13, 2022, the RVRSA Executive Director was notified by RVRSA Plant Manager that Oxidation Ditch #3 was used during an unnamed storm event and needed to ensure a safe work environment and public safety and welfare; and

WHEREAS, due to current staffing shortage associated with a COVID outbreak at the Authority, the work to clean the oxidation ditch could not be performed until the week of April 18, 2022; and

WHEREAS, the equipment needed to provide odor control measures is as provided in proposal dated April 13, 2022, attached herein and made a part of, for a not to exceed amount of \$8,280.00; and

WHEREAS, under the Local Public Contracts Law, N.J.S.A. 40A:11-6, requisitions for procurement of services or goods may be awarded without public advertising for bids and bidding when an emergency affecting the public health, safety or welfare requires the immediate performance of said services; and

WHEREAS, the RVRSA is satisfied that, for the reasons articulated by JoAnn Mondsini, Executive Director, RVRSA in the written request attached hereto and made a part hereof, the proposed emergency procurement is justified and meets the requirements of the Local Public Contracts Law and N.J.A.C. 5:34-6.1; and

WHEREAS, funds are available therefore from line 01-506-030.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

- The RVRSA declares that an emergency existed due to the immediate need to secure and
 to initiate actions to implement odor control measures which is essential and vital to ensure
 employee/public safety and welfare, and as such an emergency is declared requiring
 immediate procurement of labor, equipment, parts and repair services in an amount not to
 exceed \$8,280.00.
- 2. The Executive Director is authorized to issue purchase orders for the provision of emergency services for emergency odor control measures, as described in the Certification attached and countersigned by the B. K. Sandy Thai, Chief Financial Officer with:
 - Bio Triad Environmental., Inc., with offices at 11 Foundry Street, Unit 109, Stroudsburg, PA 18360.
- This Resolution shall take effect as provided by law.

I do hereby certify as follows:

- Emergency procurement of Odor Control services are needed with respect to the cleaning of Oxidation Ditch #3 by Bio Triad Environmental Inc.;
- 2. An actual or imminent emergency exists requiring the need to immediately take actions to ensure the safety and welfare of the public and RVRSA employees before and during the cleaning of oxidation ditch #3, which otherwise would be deleterious to public health and welfare;

I have reviewed the rules and regulations of the Division of Local Governmental Services as contained in the Local Public Contract Guidelines and Regulations and have reviewed the exceptions to the bidding requirements of the Local Public Contracts Law and hereby certify that the presented purchase requisitions may be issued as an extraordinary, unspecifiable service in accordance with the requirements thereof.
