

**RESOLUTION AUTHORIZING AMENDMENT OF CONTRACT WITH MOTT-MACDONALD TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR NJEIFP (IBANK) LOAN ASSISTANCE, DESIGN, BID PHASE AND CONSTRUCTION PHASE ENGINEERING SERVICES FOR CONTRACT 43 - BOONTON INTERCEPTOR SIPHON CHAMBERS AND WASHINGTON STREET PIPE REPLACEMENT PROJECT**

**WHEREAS**, by Resolution 21-091, adopted August 12, 2021, the RVRSA authorized a contract to provide professional engineering services for NJEIFP (I-Bank) Loan Assistance, Design, Bid Phase and Construction Phase Engineering Services for the RVRSA Boonton Interceptor Siphon Chambers and Washington Street Pipe Replacement Project (Contract 43) to Mott MacDonald, having an office at 111 Wood Avenue South, Iselin, New Jersey, in an amount not to exceed \$420,550.00 without prior authorization; and

**WHEREAS**, the RVRSA has received a proposal from Nancy C. Wohlleb, P.E., C.M.E., Env SP Vice President, Mott MacDonald, dated May 5, 2022, attached hereto, to separate work associated with the Jersey City Trunkline Reservoir portion of the plans and specifications due to the emerging reservoir issue, as set forth therein; and

**WHEREAS**, the RVRSA desires to authorize Mott MacDonald to undertake additional services as set forth in the proposal for the same dated May 5, 2022, attached hereto and made a part hereof, in an amount not to exceed \$ 39,150.00 without prior authorization, for a new total contract amount of \$ 459,700; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40:11-1 et seq.) authorizes contracts for the provision of "Professional Services," which may be awarded without public advertising and competitive bidding, provided a brief notice of the nature, duration, service, and amount of contract is published, and that the Resolution and contract are kept on file and available for public inspection; and

**WHEREAS**, funds are available for these purposes at line item 01-853-012.

**NOW, THEREFORE, BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority as follows:

1. The Executive Director of the Rockaway Valley Regional Sewerage Authority is hereby authorized and directed to execute an amendment to the existing contract for NJEIFP (I-Bank) Loan Assistance, Design, Bid Phase and Construction Phase Engineering Services for the RVRSA Boonton Interceptor Siphon Chambers and Washington Street Pipe Replacement Project (Contract 43), with the firm of Mott MacDonald, having an office at 111 Wood Avenue South, Edison, New Jersey, in accordance with proposal dated May 5, 2022, attached hereto and made a part of, in an amount not to

exceed \$39,150.00 without prior authorization, for a new total contract amount for engineering services of \$459,700.00, and conditioned upon the submission by Mott MacDonald of copies of its New Jersey Business Registration Certificate and Business Entity Disclosure Certification, insurance and any and all documents required by law or as may be required by RVRSA.

2. This contract is awarded without competitive bidding as a "Professional Service" pursuant to the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-5.
3. A notice of contract award shall be published in the official newspaper, stating the nature, duration, service, and amount of the contract, and that the Resolution and contract are on file and available for public inspection at the RVRSA.
4. This Resolution shall take effect as provided by law.


