

**RESOLUTION REVISING RESOLUTION 21-090 AND AUTHORIZING AMENDMENT  
TO APPLICATION FOR INCREASE IN LOAN AMOUNT FROM I-BANK FOR  
CONTRACT 43 BOONTON INTERCEPTOR SIPHON CHAMBERS AND  
WASHINGTON STREET PIPE REPLACEMENT PROJECT**

**WHEREAS**, by Resolution 09-052, the Rockaway Valley Regional Sewerage Authority (“RVRSA”) approved application with the New Jersey Department of Environmental Protection and New Jersey Environmental Infrastructure Trust with respect to Contract 35 Rebid 2 Contract No. 35 Rebid 2 – “Rockaway River Regional Interceptor Boonton Section Replacement Project,” and authorized the execution of the Clean Water Letter of Intent and commitment to meet the project document submittal deadlines established by the Trust and NJDEP for Participation in the Financing Program and Interim Financing; and

**WHEREAS**, by Resolution 09-060, adopted June 11, 2009, the RVRSA approved a Resolution Authorizing the Issuance of not exceeding \$3,500,000 Bonds (Series 2009) of the Rockaway Valley Regional Sewerage Authority and Providing For Their Sale To the New Jersey Environmental Infrastructure Trust and the State of New Jersey and Authorizing the Execution and Delivery of Certain Agreements in Connection Therewith, associated with Contract 35 Rebid 2; and

**WHEREAS**, by Resolution 20-007, adopted January 9, 2020, the RVRSA approved a Resolution Authorizing the Award of Contract No. 35 Rebid 2 – “Rockaway River Regional Interceptor Boonton Section Replacement Project,” with Kulpeksa Land Imp Corp., 248 Franklin Avenue, Rockaway, New Jersey (hereinafter the “Contractor”) and subject to Approval of Award by the New Jersey Department of Environmental Protection; and

**WHEREAS**, by Resolution 20-106, adopted December 10, 2020, the RVRSA approved a

Resolution Authorizing an additional loan application to obtain additional funds from the I-Bank, in the amount of three million dollars (\$3,000,000) for a period of thirty-years, from the I-Bank with respect to Contract 35 Rebid 2 "Rockaway River Regional Interceptor Boonton Section Replacement Project;" and

**WHEREAS**, by Resolution 21-090, adopted August 12, 2021, the RVRSA approved the redesign of a portion of that work anticipated to be performed as part of Contract 35 Rebid 2 - "Rockaway River Regional Interceptor Boonton Section Replacement Project" and included additional work on the Boonton Interceptor siphon chambers and Washington Street pipe replacement, which work shall has been redesignated "Contract 43 – Boonton Interceptor Siphon Chambers and Washington Street Pipe Replacement Project." Contract 43 will complete the work started under Contract 35 Rebid II, and adds the Rehabilitation of the Siphon Inlet Chamber and provided the opportunity to conduct additional investigative work in advance of a future contract to rehabilitate the Siphon Cleanout Chambers and possible cleaning and lining of the Dual Siphon Pipes themselves; and

**WHEREAS**, by Resolution 21-090, adopted August 12, 2021, RVRSA authorized a new scope of work and submission of a loan application from the I-Bank, in the amount of four million dollars (\$4,000,000) for a period of thirty-years, with respect to Contract 43; and

**WHEREAS**, Nancy C. Wohlleb, P.E., C.M.E., Env Sp., of Mott MacDonald by Email dated April 25, 2022, provided RVRSA with an updated estimate of construction cost for Contract 43 of \$4,328,472.50 and;

**WHEREAS**, RVRSA desires to amend its loan application and do all things reasonable and necessary to obtain the additional funds from the I-Bank, in the new total amount of six million dollars (\$6,000,000) for a period of thirty-years, with respect to Contract 43 "Boonton Interceptor

Siphon Chambers and Washington Street Replacement Project.”

**NOW, THEREFORE, BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority as follows:

1. Resolution 21-090 is hereby revised in accordance herewith and the Executive Director is authorized and directed to act as the Authorized Representative to the Rockaway Valley Regional Sewerage Authority in all matters relating to the project undertaken pursuant to the above referenced New Jersey Environmental Infrastructure Loan to be executed with the New Jersey Department of Environmental Protection and the New Jersey I-Bank.


