**RESOLUTION AUTHORIZING EXECUTION  
OF CONTRACT FOR  
CALCIUM NITRATE SOLUTION (58%)**

**WHEREAS**, the Rockaway Valley Regional Sewerage Authority (hereinafter "RVRSA") desires to purchase CALCIUM NITRATE SOLUTION (58%); and

**WHEREAS**, the RVRSA advertised for bid proposals to supply the RVRSA with Calcium Nitrate Solution (58%), according to bid specifications; and

**WHEREAS**, the bid of EVOQUA WATER TECHNOLOGIES LLC, located at 2650 Tallevast Road, Sarasota, Florida 34243 being the sole bidder, was reviewed by the Authority's Staff to determine compliance with the technical specifications; and

**WHEREAS**, by memorandum dated July 8, 2022, Diane Alexander, Esq. of Maraziti, Falcon LLC has determined that the bid submitted by the sole bidder EVOQUA WATER TECHNOLOGIES LLC., has met the legal requirements set forth in the bid specifications; and

**WHEREAS**, based upon the respective bid prices proposed for a twelve (12) month and a twenty-four (24) month period, Authority staff recommend that it would be in the best interest of the Authority to award the bid to EVOQUA WATER TECHNOLOGIES LLC, for a twelve (12) month period for supply of Calcium Nitrate Solution (58%); and

**WHEREAS**, the RVRSA has sufficient funds available at line item 01-507-031 for this purpose.

**NOW, THEREFORE, BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority as follows:

1. The bid for Calcium Nitrate Solution (58%) from EVOQUA WATER TECHNOLOGIES LLC., located at 2650 Tallevast Road, Sarasota, Florida 34243

be accepted in accordance with the bid specifications and the bid proposal which is on file in the offices of RVRSA in the amount of:

**Calcium Nitrate Solution (58%) \$2.91/gallon (Months 1 to 12)**

2. The Executive Director is authorized and directed to execute a twelve (12) month contract for supplying Calcium Nitrate Solution (58%) to EVOQUA WATER TECHNOLOGIES LLC., in accordance with the bid proposal for the same submitted July 7, 2022.
3. A copy of the resolution and contract shall be kept available for public inspection at the RVRSA office at the Administration Building, 99 Green Bank Road, Parsippany, and New Jersey.
4. This resolution shall take effect as provided by law.


