RESOLUTION TO AUTHORIZE THE EXECUTION OF CHANGE ORDER 6 TO CONTRACT NUMBER 41, PHOSPHORUS REMOVAL AND FILTRATION FACILITIES PROJECT

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter the "Authority") entered into Contract 41 for the Phosphorus Removal and Filtration Facilities Project with Coppola Services, Inc., 28 Executive Parkway, Ringwood, New Jersey (hereinafter the "Contractor"); and

WHEREAS, an addition to the contract tasks is required to be made to repair a broken water supply line, supply and install a new effluent 60-inch magnetic flow meter, and supply and install motors and controls for the filtration building garage doors, as more specifically set forth in letter dated September 2, 2022 by Nancy Wohlleb, P.E., Mott MacDonald and Contract Modification Proposal and Acceptance Form CM-006, by Nancy C. Wohlleb, P.E., (Mott MacDonald); and

WHEREAS, the change referred to in the above referenced correspondence reflect a total increase in contract value of \$227,812.74 or approximately 2.10% of the original contract award as follows; and
