RESOLUTION AUTHORIZING THE EXECUTION OF CHANGE ORDER 7 TO CONTRACT NUMBER 41, PHOSPHORUS REMOVAL AND FILTRATION FACILITIES PROJECT

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter the "Authority") entered into Contract 41 for the Phosphorus Removal and Filtration Facilities Project with Coppola Services, Inc., 28 Executive Parkway, Ringwood, New Jersey (hereinafter the "Contractor"); and

WHEREAS, an addition to the contract tasks is required to be made for an allowance for demolition and removal of existing concrete duct bank, for pull-back and coiling of live conductors in MH-19, for disconnecting and removal of direct bury conductors and an allowance for providing temporary power to existing equipment, as necessary, as more specifically set forth in letter dated November 4, 2022 and Contract Modification Proposal and Acceptance Form CM-007, by Nancy C. Wohlleb, P.E., (Mott MacDonald); and

WHEREAS, the change referred to in the above referenced correspondence and CM-007 reflect a total increase in contract allowance value of not to exceed \$75,000.00 (approximately 0.69%) of the original contract price and when added together with prior change orders totaling \$143,024.72 results in an approximate 2% increase of the original contract price in the event that the entire allowance items below are utilized, together with a zero-day time extension as follows:

- 1. Subject to receipt of New Jersey Department of Environmental Protection approval, the Authority hereby approves Change Order No. 7 for the additional allowance amounts of \$75,000.00.
- 2. Upon receipt of New Jersey Department of Environmental Protection approval, the Executive Director is hereby authorized and directed to execute a Contract Change Order CM-007 substantially in the form as that attached hereto, in the foregoing amount and for a zero-day time extension.
 - 3. This Resolution shall take effect as provided by law.
