

## RESOLUTION 22-113

### RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR SODIUM HYPOCHLORITE SOLUTION

**WHEREAS**, the Rockaway Valley Regional Sewerage Authority (hereinafter “RVRSA”) desires to purchase Sodium Hypochlorite solution (15%); and

**WHEREAS**, the RVRSA issued a Notice to Bidders seeking sealed competitive bids for the supply of sodium hypochlorite solution according to bid specifications, for a twelve (12) month period and for a twenty-four (24) month period; and

**WHEREAS**, the Authority received sealed competitive bids on December 6, 2022 from four bidders in the following amounts:

Bidder	months 1-12	months 13-24
Univar Solutions USA, Inc.	\$ 2.20/gallon	no bid
Miracle Chemical	\$ 4.54/gallon	no bid
Kuehne Company	\$ 2.95/gallon	\$ 3.50/gallon

**WHEREAS**, the bid submitted by the apparent lowest responsible bidder, Univar Solutions USA, Inc. , was reviewed by the Authority’s staff and the Authority’s legal counsel, Maraziti Falcon LLP, to determine compliance with the technical specifications and procurement laws; and

**WHEREAS**, based upon this review, it has been determined that the bid submitted by the apparent lowest responsible bidder, Univar Solution USA, Inc., has met the legal and technical requirements set forth in the bid specifications; and

**WHEREAS**, Authority Staff recommend that it would be in the best interests of the Authority to award the bid to Univar Solutions USA, Inc. for the supply of sodium hypochlorite solution for a twelve (12) month period; and

**WHEREAS**, the RVRSA has sufficient funds available at line item 01-506-033 for these purposes.

**NOW THEREFORE BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority on this 8<sup>th</sup> day of December, 2022 as follows:

1. The bid for Sodium Hypochlorite Solution (15%) from Univar Solutions USA, Inc., of 200 Dean Sievers Place, Morrisville, PA 19067, is hereby accepted in accordance with the bid specifications and the bid proposal which is on file in the offices of RVRSA in the amount of Hypochlorite Solution (15%) \$2.20/gallon for months one (1) through twelve (12).
2. The Executive Director is authorized and directed to execute a twelve (12) month contract for supplying Hypochlorite Solution (15%) to Univar Solutions USA, Inc., in accordance with the bid for the same submitted December 6, 2022.
4. A copy of the resolution and contract shall be kept available for public inspection at the RVRSA office at the Administration Building, 99 Green Bank Road, Parsippany, and New Jersey.


