RESOLUTION AMENDING RESOLUTON 21-109 AUTHORIZING APPLICATION FOR A LOAN FROM THE NEW JERSEY I-BANK FOR PHASE 1 – EMERGENCY GENERATORS AND SWITCHGEAR REPLACEMENT PROJECT

WHEREAS, the Rockaway Valley Regional Sewerage Authority ("Authority") is desirous of replacing its Emergency Generators and Main Switchgear Facilities ("Phase 1 – Emergency Generators and Main Switchgear Replacement Project – Contract 44") and accordingly intends to file an application with the New Jersey Department of Environmental Protection and the New Jersey I-Bank for a loan in an amount of \$8,000,000 for Phase 1 – Emergency Generators and Main Switchgear Project – Contract 44; and

WHEREAS, RVRSA's Engineer, Tim Bradley, P.E. of Kleinfelder, LLC, completed and submitted to the RVRSA an updated Report entitled, "RVRSA WWTP Emergency Generator Replacement Alternatives Summary – August 2023 Update" and an updated Construction Cost Estimate, dated August 17, 2023, for Phase 1 – Emergency Generators and Main Switchgear; and

WHEREAS, the updated estimated construction cost provided by Kleinfelder, LLC is \$11.2 Million Dollars and the calculated I-Bank loan amount is estimated to be \$13.0 Million Dollars; and

WHEREAS, pursuant to Authority Resolution 21-109, the Authority filed a loan application relating the project and is now desirous of amending that resolution and application to reflect the updated estimated construction cost; and

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

- 1. The Executive Director is authorized and directed to act as the Authorized Representative of the Rockaway Valley Regional Sewerage Authority in all matters relating to Phase 1 Emergency Generators and Main Switchgear Replacement Project, Contract No. 44, and the application to be submitted to the New Jersey Department of Environmental Protection and the New Jersey I-Bank.
