## Resolution 23-112

RESOLUTION AUTHORIZING AMENDMENT OF RESOLUTION 20-052, ENDORSEMENT OF APPLICATION FOR TREATMENT WORKS APPROVAL (TWA-1) 360 FRANKLIN AVENUE, TOWNSHIP OF DENVILLE, TO CORRECT THE GALLONAGE ALLOCATED FROM RVRSA'S "FIRST COME/FIRST SERVE" CATEGORY TO THE PROJECT

WHEREAS, by Resolution 20-052, adopted May 14, 2020 and attached hereto, RVRSA approved an application for Treatment Works Approval submitted by the Township of Denville ("Denville") which proposed the construction and connection of 3,950 LF of 8- inch diameter PVC gravity main to the existing sewer system in Franklin Avenue for the extension of sanitary sewer to serve five (5) one bedroom units, fourteen (14) two bedroom units, and ninety-seven (97) three bedroom units and one clubhouse in twenty-four (24) buildings, for a total of 116 dwelling units, 24 of which are to be affordable housing units (the "Project") at 360 Franklin Avenue, within Block 40001, Lot 4 and Block 40203, Lot 1, Township of Denville; and

WHEREAS, Resolution 20-052 incorrectly established that pursuant to RVRSA's planning estimates, the gallonage required to service the proposed Project is in the amount of 24,391 GPD, however, the correct gallonage required to service the project utilizing RVRSA planning estimates is 20,349; and

WHEREAS, RVRSA desires to amend Resolution 20-052 with regard to correcting the RVRSA planning estimate for the project from 24,391 GPD to 20,349 GPD and to amend the allocation from RVRSA's "First Come/First Serve" category from 24,391 GPD to 20,349 GPD to serve the 360 Franklin Avenue Project.

**NOW, THEREFORE, BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority as follows:

1. Resolution 20-052 is hereby amended to correct the gallonage required to service the project utilizing RVRSA planning estimates of 20,349 and further amended to establish that there shall be allocated from RVRSA's "First Come/First Serve" category, gallonage in the amount of 20,349 GPD to serve 360 Franklin Avenue, within Block 40001, Lot 4 and Block 40203, Lot 1, in the Township of Denville.
