

**RESOLUTION TO AUTHORIZE AN AMENDMENT TO  
THE 2022 AGREEMENT WITH ALS ENVIRONMENTAL  
FOR THE PROCUREMENT OF LABORATORY SERVICES**

**WHEREAS**, by Resolution Number 21-132, adopted on December 9, 2021, the Rockaway Valley Regional Sewerage Authority (RVRSA) authorized the execution of a contract with ALS ENVIRONMENTAL for the procurement of outside laboratory services in an amount not to exceed \$39,939.00 per year for two-years; and

**WHEREAS**, an Agreement for the procurement of outside laboratory services was executed on January 1, 2022, between ALS Environmental and the Rockaway Valley Regional Sewerage Authority; and

**WHEREAS**, the laboratory manager of the RVRSA has notified the Executive Director that an additional \$1,000.00 is needed for laboratory services for Year 2023; and

**WHEREAS**, ALS Environmental has on file at the RVRSA a bid dated November 9, 2021, for the performance of said services; and

**WHEREAS**, funds are available in RVRSA account 01-505-020.

**NOW, THEREFORE BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority, on this 14th day of December 2023, as follows:

1. The Executive Director is authorized and directed to execute an Amendment to the Agreement dated December 20, 2021 between RVRSA and ALS Environmental with offices located at 10450 Stancliff Road, Suite 210, Houston, Texas 77099, so as to authorize the expenditure of an additional, not to exceed amount of \$1,000.00, for a new total contract amount of \$40,939.00 for year 2023, to be paid in accordance with the bid attached to the December 20, 2021 Agreement. All other provisions of the Agreement with ALS Environmental, shall remain in effect.
2. A copy of this Resolution shall be available for public inspection at the offices of the

RVRSa at 99 Greenbank Road, Township of Parsippany, Troy Hills, Morris County,  
New Jersey.

3. This Resolution shall take effect as provided by law.
