

RESOLUTION # 24-036

**RESOLUTION AUTHORIZING EXECUTION
OF CONTRACT FOR
ALUMINUM SULFATE 8.3% AL₂O₃ SOLUTION**

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter “RVRSA”) desires to purchase Aluminum Sulfate 8.3% AL₂O₃ (“Aluminum Sulfate”) solution for phosphorus removal; and

WHEREAS, the RVRSA advertised for bid proposals to supply the RVRSA with Aluminum Sulfate, according to bid specifications, for a twelve (12) month period with an option to renew such contract for an additional twelve (12) month period at the sole discretion of the Authority; and

WHEREAS, the RVRSA received three (3) bids on February 29, 2024 from the companies listed below at the rate shown; and

WHEREAS, the bid of CHEMTRADE CHEMICALS US, LLC, was reviewed by the Authority’s Staff to determine compliance with the technical specifications; and

WHEREAS, by memorandum dated March 8, 2024, Diane Alexander, Esq. of Maraziti, Falcon, LLP has determined that the bid submitted by Chemtrade Chemicals US, LLC. has met the legal requirements set forth in the bid specifications; and

WHEREAS, based upon its review of the bid price proposed, the Authority has determined that it would be in the best interests of the Authority to award the bid to Chemtrade Chemicals US, LLC., for a term of twelve (12) months with an option to extend the contract for an additional twelve (12) month period, exercisable at the sole discretion of the Authority and subject to the availability of financing therefore. The Authority will provide thirty (30) days’ written notice if it exercises its option to extend; and

WHEREAS, the CFO has certified that sufficient funds are available in line item 01-506-037.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

1. All immaterial defects contained in the bid submission of Chemtrade Chemical US, LLC, if any, are waived and a contract for Aluminum Sulfate 8.3% AL_2O_3 (Aluminum Sulfate) solution is awarded to Chemtrade Chemicals US, LLC, 90 East Halsey Road, Suite 200, Parsippany, NJ 07054 in accordance with the bid specifications and the bid proposal which is on file in the offices of RVRSA in the amount of:

\$ 1.2150/gal for months 1-12, and
\$ 1.2150/gal for months 13-24

2. The Executive Director is authorized and directed to execute a contract for supplying Aluminum Sulfate 8.3% AL_2O_3 (Aluminum Sulfate) to Chemtrade Chemicals US, LLC., in accordance with the proposal for the same submitted February 29, 2024, for a term of twelve (12) months with an option to extend the contract for an additional twelve (12) month period, exercisable at the sole discretion of the Authority and subject to the availability of financing therefore. The Authority will provide thirty (30) days' written notice if it exercises its option to extend the contract.
3. A copy of the resolution and contract shall be kept available for public inspection at the RVRSA office at the Administration Building, 99 Green Bank Road, Parsippany, and New Jersey.
4. This resolution shall take effect as provided by law.
