The Executive Director, JoAnn Mondsin, is hereby authorized to issue a public notice of the commencement of the 30-day public comment period, in accordance with N.J.A.C. 7:14A-15.10 and N.J.A.C. 7:14A-15.11, prior to consideration of an Industrial Sewer Connection Permit Renewal, including consideration of a Variance for CBOD Concentration, for Cibao Meat Products, 92 Green Pond Road, Township of Rockaway, NJ.

The proposed form of Industrial Sewer Connection Permit, with CBOD concentration Variance, is marked Schedule "A," attached hereto and made a part hereof, a copy of which is also on file at the offices of RVRSA. The terms and conditions proposed include, renewal of existing terms and conditions, and updating of effluent limitations consistent with local limits study dated November 2014, last revised December 2016, including the April 14, 2017, Addendum, approved by NJDEP on April 24, 2017.



RECEIVING COLLECTION SYSTEM: Local collection system owned and operated by the Township of Rockaway.

DESCRIPTION OF FACILITY OPERATIONS:

Cibao Meat Products, Inc. (Cibao Meat)'s primary activities are the food processing of frozen meats, fresh meats, poultry. Processing includes grinding, stuffing, smoking, cooking, cooling, packaging, cleaning/sanitization of the processing equipment and warehousing of the final product. Cibao Meat's SIC code is 2013 (Sausages and Other Prepared Meat Products). This facility is classified as an Industrial User of Concern, discharging **10,225** gallons per day (GPD) monthly average of combined waste streams generated from its packaging facility and offices. The wastewater is being pretreated prior to discharge. Pretreatment consists of grease traps as per the RVRSA Addendum to Service Rules, Regulations Concerning Industrial Users and General Sewer Use Requirements: Section 200: General Sewer Use Requirements: 201: Prohibited Wastes: C. Grease, Oil, and Sand Interceptors.

SUMMARY OF VARIANCE REQUEST:

The RVRSA local limit for CBOD₅ is 250 mg/l. Discharges of CBOD₅ require a Variance in accordance with RVRSA Service Rules. Discharges above 250 mg/l are also subject to the Surcharge for Wastewaters of Excessive Strength as per Section 8B of this ISCP.

Cibao Meat Products has requested a discharge limit for CBOD₅ limit of 1,400 mg/l. Discharges greater than the above stated limitation will be considered a permit violation and subject to applicable enforcement actions.

By memo dated, April 19, 2024, Natalie Pisarcik, IPP Coordinator and One Water Consulting have reviewed the CBOD loading associated with this Variance Application and have determined that the requested loading is within available Plant Loading for the RVRSA.

Cibao Meat Products has provided detailed application in support of its request for a Variance.

The Township of Rockaway has been notified and has notified the RVRSA that it does not object to the Request for a variance.

The Variance will be public noticed with the public notice for Cibao Meat Products Permit Renewal for a 30-day comment period prior to RVRSA Board approval.
