## RESOLUTION TO AUTHORIZE THE EXECUTION OF CHANGE ORDER 2 TO CONTRACT NUMBER 43, INTERCEPTOR SEWER REPLACEMENT AND REHABILITATION - BOONTON SECTION

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter the "Authority") entered into Contract 43 for the Interceptor Sewer Replacement and Rehabilitation - Boonton Section Project with Spiniello Companies, 354 Eisenhower Parkway, Livingston, NJ 07039 (hereinafter the "Contractor"); and

WHEREAS, certain additions to the contract tasks are required to be made, namely, installation of doghouse manhole structure with weir wall over existing 24-inch and 30-inch siphon pipes located 50-feet below the Boonton Siphon Inlet Chamber, replace approximately 50-feet of 24-inch and 30-inch pipe with HOBAS pipe, and time extension of 30-days to the Contract, as more specifically set forth in the Contract Modification Proposal and Acceptance Form, dated June 3, 2024 by Mark Montesano, P.E., (Mott MacDonald); and

WHEREAS, the changes referred to in the above referenced correspondence are reflect a total increase in contract value of \$650,000.00 or approximately 17.27% of the original contract award as follows; and

1. Subject to receipt of New Jersey Department of Environmental Protection approval, the Authority hereby approves Change Order No. 2, in a not to exceed amount of \$650,000.00 and a non-compensable time extension of 30-days.
