**RESOLUTION AUTHORIZING EXECUTION OF CONTRACT WITH  
ONE WATER CONSULTING, LLC TO PROVIDE PROFESSIONAL  
ENGINEERING SERVICES FOR DESIGN, BID PHASE AND  
CONSTRUCTION PHASE ENGINEERING SERVICES FOR CONTRACT  
FOR FURNISHING AND INSTALLATION OF NEW EFFLUENT METER  
PROJECT**

**WHEREAS**, the RVRSA is desirous of authorizing a contract to provide professional engineering services for Design, Bid Phase and Construction Phase Engineering Services for Furnishing and Installation of New Effluent Meter Project; and

**WHEREAS**, the firm of One Water Consulting, LLC, 101 Poor Farm Road, 2<sup>nd</sup> Floor, Princeton, New Jersey, 08540 submitted a Proposal dated July 19, 2024, which proposal is on file at the offices of the Rockaway Valley Regional Sewerage Authority (“RVRSA”), for the performance of such professional services; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40:11-1 et seq.) authorizes contracts for the provision of “Professional Services,” which may be awarded without public advertising and competitive bidding, provided a brief notice of the nature, duration, service, and amount of contract is published, and that the Resolution and contract are kept on file and available for public inspection; and

**WHEREAS**, funds are available for these purposes at line item 01-853-022.

**NOW, THEREFORE, BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority as follows:

1. The Rockaway Valley Regional Sewerage Authority recognizes that One Water Consulting, LLC has an established reputation in the field of engineering matters related to the services set forth in the letter proposals on file at the offices of the Rockaway Valley Regional Sewerage Authority and recognizes that they possess specialized abilities and resources to provide the expert engineering services necessary to meet the Authority’s needs.
2. The Executive Director of the Rockaway Valley Regional Sewerage Authority is hereby authorized and directed to execute a contract for professional services, in a form acceptable to the Executive Director and Counsel, between the Rockaway Valley Regional Sewerage Authority and the firm of One Water Consulting, LLC, having an office at 101 Poor Farm Road, 2<sup>nd</sup> Floor, Princeton, New Jersey, for Design, Bid Phase and Construction Phase Engineering Services for Furnishing and Installation of New Effluent Meter Project, at a cost not to exceed \$87,600.00

without further authorization, to be calculated in accordance with the proposal dated July 19, 2024, attached hereto at Schedule A, and conditioned upon the submission by One Water Consulting, LLC of its New Jersey Business Registration Certificate and Business Entity Disclosure Certification.

3. This contract is awarded without competitive bidding as a “Professional Service” under the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-5.
4. A notice of contract award shall be published in the official newspaper, a brief notice stating the nature, duration, service, and amount of the contract, and that the Resolution and contract are on file and available for public inspection at the Authority.
5. This Resolution shall take effect as provided by law.


