RESOLUTION TO AUTHORIZE THE EXECUTION OF CHANGE ORDER 3 TO CONTRACT NUMBER 43. INTERCEPTOR SEWER REPLACEMENT AND REHABILITATION - BOONTON SECTION

WHEREAS, the Rockaway Valley Regional Sewerage Authority (hereinafter the "Authority") entered into Contract 43 for the Interceptor Sewer Replacement and Rehabilitation - Boonton Section Project with Spiniello Companies, 354 Eisenhower Parkway, Livingston, NJ 07039 (hereinafter the "Contractor"); and

WHEREAS, a three-hundred-sixty-five (365) calendar day time extension is required for completion of the Contract Work for the Interceptor Sewer Rehabilitation and Replacement – Boonton Section Project, in part due to the County requirements for the permanent road restoration work to be performed in Spring 2025, as set forth in the Contract Modification Proposal and Acceptance Form, dated September 5, 2024 by Mark Montesano, P.E., (Mott MacDonald).

WHEREAS, the changes referred to in the above referenced correspondence are reflect a total increase in contract value of \$0.00 or approximately 0.0% of the original contract award as follows; and
