

Resolution 24-093

RESOLUTION AUTHORIZING THE AMENDMENT OF THE
CONTRACT WITH ATLANTIC TOMORROWS OFFICE FOR THE
PROCUREMENT OF COMPUTER SERVICES RELEVANT TO THE
MAINTENANCE AND INTEGRATION OF THE RVRSA'S EXISTING
COMPUTER SYSTEMS

WHEREAS, the Rockaway Valley Regional Sewerage Authority ("RVRSA") requires computer IT services and the provision of support and maintenance of the same; and

WHEREAS, the retention of such computer services is estimated to exceed \$17,500.00, and which services may be procured based on a fair and open process and under the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, Atlantic Tomorrows Office, having a business address of 310 Commerce Drive, Moorestown, NJ, has provided the attached proposal, dated December 6, 2023, and February 26, 2024, for the provision or performance of goods or services for the support or maintenance of proprietary computer hardware and software; and

WHEREAS, by Resolution Number 23-121, adopted on December 14, 2023, the Rockaway Valley Regional Sewerage Authority (RVRSA) authorized the execution of a contract with Atlantic Tomorrow's Office for the provision or performance of goods or services for the support or maintenance of proprietary computer hardware and software outside laboratory services in an amount not to exceed \$82,000.00; and

WHEREAS, under the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(dd), a contract may be awarded without public advertising for bids and bidding for the provision or performance of goods or services for the support of maintenance of proprietary computer hardware and software, provided that this exemption shall not be utilized to acquire or upgrade non-proprietary hardware or to acquire or update non-proprietary software; and

WHEREAS, the Authority desires to amend the contract with Atlantic Tomorrows Office to

increase the amount of the contract by \$9,100.00 for a new total contract amount of \$91,100.00

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority, as follows:

1. The Rockaway Valley Regional Sewerage Authority does hereby award an increase in the contract with Atlantic Tomorrows Office for computer services, in an amount not to exceed \$91,100.00 without further authorization of the Authority.
2. A copy of this Resolution shall be published in accordance with N.J.S.A. 40A:11-5(a)(i).
3. This Resolution shall take effect as provided by law.


