

**RESOLUTION AUTHORIZING AMENDMENT OF CONTRACT FOR ANNUAL HVAC AND PLUMBING SERVICES**

**WHEREAS**, the Rockaway Valley Regional Sewerage Authority (the "Authority") requires on-call and annual service to its HVAC and Plumbing systems; and

**WHEREAS**, the Authority has found it necessary to contract an outside vendor to provide these services; and

**WHEREAS**, in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11A-1 et seq., when the cost or price of any contract awarded by the contracting unit does not exceed the bid threshold, the contract may be awarded by the contracting unit without public advertisement for bids; and

**WHEREAS**, as set forth in the Quotation Record Form dated January 8, 2024 attached hereto and made a part hereof, at least two competitive quotations were sought for the performance of on-call and annual HVAC and Plumbing services and in response the Authority received the lowest quotation from John Duffy Energy Services, having a business office at 465 Mulberry Street, Newark, New Jersey for the rates of Daily (7am to 3:30pm) \$125.00 per hour; and overtime rate: \$145.00 per hour; and

**WHEREAS**, by Resolution 24-025, adopted on February 8, 2024, the RVRSA authorized execution of a contract with John Duffy Energy Services in the amount of \$23,000.00; and

**WHEREAS**, the RVRSA Electric Engineer has requested additional funds to complete HVAC service to the rooftop units of the Process Building, in the amount of \$10,000.00; and

**WHEREAS**, the Authority is desirous of increasing the contract value by an additional \$10,000.00 for a new contract amount of \$33,000.00; and

**WHEREAS**, funds are available for this purpose at line items 01-503-240 and 01-506-040

**NOW, THEREFORE, BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority as follows:

1. That the Executive Director is hereby authorized to execute an amendment to the HVAC and Plumbing services agreement between John Duffy Energy Services, having a business office at 465 Mulberry Street, Newark, New Jersey, and the Rockaway Valley Regional Sewerage Authority, in

- the amount of \$10,000.00 for a new not to exceed contract amount of \$33,000.00.
2. This Resolution shall take effect as provided by law.


