RESOLUTION AMENDING RESOLUTION 24-093 AUTHORIZING THE AMENDMENT OF THE CONTRACT WITH ATLANTIC TOMORROWS OFFICE FOR THE PROCUREMENT OF COMPUTER SERVICES RELEVANT TO THE MAINTENANCE AND INTEGRATION OF THE RVRSA'S EXISTING COMPUTER SYSTEMS

WHEREAS, the Rockaway Valley Regional Sewerage Authority ("RVRSA") requires computer IT services and the provision of support and maintenance of the same; and

WHEREAS, the retention of such computer services is estimated to exceed \$17,500.00, and which services may be procured based on a fair and open process and under the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, Atlantic Tomorrows Office, having a business address of 310 Commerce Drive, Moorestown, NJ, has provided the attached proposal, dated December 6, 2023, and February 26, 2024, for the provision or performance of goods or services for the support or maintenance of proprietary computer hardware and software; and

WHEREAS, by Resolution Number 23-121, adopted on December 14, 2023, the RVRSA authorized the execution of a contract with Atlantic Tomorrow's Office for the provision or performance of goods or services for the support or maintenance of proprietary computer hardware and software computer services in an amount not to exceed \$82,000.00; and

WHEREAS, under the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(dd), a contract may be awarded without public advertising for bids and bidding for the provision or performance of goods or services for the support of maintenance of proprietary computer hardware and software, provided that this exemption shall not be utilized to acquire or upgrade non-proprietary hardware or to acquire or update non-proprietary software; and

WHEREAS, by Resolution Number 24-093, adopted on October 10, 2024, the RVRSA authorized a contract amendment in the amount of \$9,100.00 for additional services to supply and install Resolution 24-109

a new server, including hardware, software and installation services, and the Executive Director later found that the amount of contract amendment needed is \$17,000.00; and

WHEREAS, the Authority desires to amend Resolution 24-093 to increase the amount of the contract by \$17,000.00 for a new total contract amount of \$99,000.00

WHEREAS, funds are available for these purposes at line-item 01-501-025.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority, as follows:

- 1. The Rockaway Valley Regional Sewerage Authority hereby amends Resolution 24-093 to increase the contract amendment amount stated therein from \$9,900.00 to \$17,000.00.
- 2. The Executive Director is authorized and directed to execute an amendment to the contract with Atlantic Tomorrow's Office for computer services, in the amount of \$17,000.00, for a new total not to exceed contract amount of \$99,000.00 without further authorization of the Authority.
- 3. A copy of this Resolution shall be published in accordance with N.J.S.A. 40A:11-5(a)(i).
- 4. This Resolution shall take effect as provided by law.
