RESOLUTION AUTHORIZING NOTICE AND PUBLIC HEARING PRIOR TO THE ADOPTION OF THE ROCKAWAY VALLEY REGIONAL SEWERAGE AUTHORITY EXCESS POLLUTANT SURCHARGE PROGRAM UPDATE

and shall hold a public hearing on Thursday, February 13, 2024 at 6:30 pm, or as soon thereafter

as the public may be heard, at the RVRSA Administration Building, 99 Green Bank Road,

Parsippany, New Jersey, prior to further consideration of the adoption of the Excess Pollutant

Surcharge Program 2024 Update.
