

RESOLUTION 25-043

RESOLUTION AUTHORIZING THE AWARD OF CONTRACTS FOR EMERGENCY RESPONSE SERVICES

WHEREAS, the Rockaway Valley Regional Sewerage Authority (RVRSA) operates a wastewater conveyance and treatment system pursuant to the terms and conditions of the Water Pollution Control Act, applicable regulations and in accordance with the terms and conditions of its New Jersey Pollutant Discharge Elimination System (NJPDES) wastewater discharge permit; and

WHEREAS, emergency response services, that cannot be anticipated in scope or time, are periodically needed to protect human health, worker health and safety and the environment; and

WHEREAS, the RVRSA solicited two quotes attached, for hourly rates for emergency response services to respond to discharges of oil or other hazardous substances; and

WHEREAS, the Authority desires to award a contract for the performance of such standby emergency response work to Clean Harbors Environmental Services, Inc., with offices at 42 Longwater Drive, P.O. Box 9149, Norwell, Massachusetts, 02061-9149, in accordance with the rate schedule attached; and

WHEREAS, the Authority also desires to award a contract for the performance of such standby emergency response work to Clean Earth Environmental Solutions, Inc., with offices at 933 First Avenue, Suite 200, King of Prussia, Pennsylvania 19406, in accordance with the rate schedule attached; and

WHEREAS, no funds are being expended at this time.

NOW THEREFORE, BE IT RESOLVED that the Rockaway Valley Regional Sewerage Authority as follows:

1. The Authority hereby authorizes the Executive Director to enter into a contract in a form at least as favorable to the Authority as the attached, with Clean Harbors Environmental Services, Inc., with offices at 42 Longwater Drive, P.O. Box 9149, Norwell, Massachusetts, 02061-9149 to affect emergency response services to the RVRSA, as the need arises, in accordance with the rate schedule attached.
2. The Authority hereby authorizes the Executive Director to enter into a contract in a form at least as favorable to the Authority as the attached, with Clean Earth Environmental Solutions, Inc., with offices at 933 First Avenue, Suite 200, King of Prussia, Pennsylvania 19406 to affect emergency response services to the RVRSA, as the need arises, in accordance with the rate schedule attached.
3. The Authority hereby designates the Executive Director as the Customer Representative with regard to the aforementioned emergency response contracts.
4. The Executive Director shall cause a copy of the within Resolution to be published in an official newspaper of the Authority.
5. This Resolution shall take effect immediately.
