RESOLUTION AUTHORIZING EXECUTION OF CONTRACT FOR ORGANIC POLYELECTROLYTE (Polymer)

WHEREAS, the bid of SNF Polydyne Inc., was reviewed by the Authority's Staff to determine compliance with the technical specifications; and

WHEREAS, by memorandum dated June 5, 2025, Diane Alexander, Esq. of Maraziti, Falcon, LLP has determined that the bid submitted by SNF Polydyne, Inc. has met the legal requirements set forth in the bid specifications; and

WHEREAS, based upon its review of the bid prices proposed, the Authority has determined that it would be in the best interests of the Authority to award the bid to SNF Polydyne Inc., for a term of two years subject to the availability of funds in Year two (2); and

WHEREAS, the CFO has certified that sufficient funds are available in line item 01-506-035.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

1. The bid for Organic Polyelectrolyte (Polymer) from SNF Polydyne Inc., One Chemical Plant Road, Riceboro, GA 31232 be accepted in accordance with the bid specifications and the bid proposal which is on file in the offices of RVRSA in the amount of:

2. The Executive Director is authorized and directed to execute a contract for supplying Organic Polyelectrolyte (Polymer) to SNF Polydyne Inc., in accordance with the proposal for the same submitted June 5, 2025, for a term of twenty-for (24)

months, subject to availability of funds for months 13-24.

3. A copy of the resolution and contract shall be kept available for public inspection at the RVRSA office at the Administration Building, 99 Green Bank Road,

Parsippany, and New Jersey.

4. This resolution shall take effect as provided by law.
