

**RESOLUTION AUTHORIZING AWARD OF SHORT-TERM AND  
LONG-TERM DISABILITY INSURANCE POLICY CONTRACT WITH  
MUTUAL OF OMAHA LIFE INSURANCE COMPANY**

**WHEREAS**, the Rockaway Valley Regional Sewerage Authority (RVRSA) maintains policies providing for short-term and long-term disability insurance; and

**WHEREAS**, the RVRSA has received quotations from Mutual of Omaha and Hartford, therefore, and

**WHEREAS**, the Authority desires to terminate its policy with Hartford Life and Accident Insurance Company, located at One Hartford Plaza, Hartford, Connecticut, effective August 31, 2025, and award short-term and long-term disability coverage to the Mutual of Omaha Life Insurance Company, 3301 Dodge Street, Omaha, Nebraska 68175, effective September 1, 2025; and

**WHEREAS**, N.J.S.A. 40:11-5(1)(m) authorizes the Authority to award contracts for insurance without public advertising for bids and bidding thereof; and

**WHEREAS**, funds are available for this purpose at line items 01-501-207 and 01-501-208.

**NOW, THEREFORE, BE IT RESOLVED** by the Rockaway Valley Regional Sewerage Authority as follows:

1. The Authority hereby terminates, effective August 31, 2018, its existing short-term and long-term insurance policies with Hartford Life and Accident Insurance Company and approves and authorizes the Executive Director to acquire a short-term and long-term disability insurance policy with the Mutual of Omaha Insurance Company, with offices at 3301 Dodge Street, Omaha, Nebraska 68175, effective September 1, 2025.
2. The Authority hereby authorizes payment to the Mutual Omaha Insurance Company of the premiums due in the total amount not to exceed \$5,000.00 and \$6,000.00, in order to obtain the short-term disability and long-term disability policies, respectively.
3. The Executive Director shall cause a copy of the within Resolution to be published in an official newspaper of the Authority.
4. This Resolution shall take effect immediately.


