

**RESOLUTION AUTHORIZING AMENDMENT TO CONTRACT FOR
DRUG AND ALCOHOL TESTING WITH VALLEY HEALTH SYSTEM,
INC.**

WHEREAS, the Rockaway Valley Regional Sewerage Authority (RVRSA) contracted with Valley Health System, Inc., for CDL alcohol and drug testing services; and

WHEREAS, by Resolution 26-002, adopted on January 8, 2026, the RVRSA authorized execution of a contract with Valley Health System, Inc., for the period January 1, 2026 to December 31, 2026, in an amount not to exceed \$1,000.00; and

WHEREAS, Valley Health System, Inc. has revised its contract period to April 1, 2026 to March 31, 2027; and

WHEREAS, additional funds are needed to pay a new Administrative fee to be charged in the amount of \$300.00; and

WHEREAS, the Authority is desirous of amending the contract term and increasing the contract value by an additional \$300.00; and

WHEREAS, the necessary funds are available in the RVRSA budget line item 01-501-120.

NOW, THEREFORE BE IT RESOLVED by the RVRSA as follows:

1. The Rockaway Valley Regional Sewerage Authority does hereby authorize the Executive Director to execute an Amendment to the Contract between the RVRSA and Valley Health System Inc., in the amount of \$300.00, without the need for further authorization, for a new total contract amount not to exceed of \$1,300.00 and amending the contract term to April 1, 2026 to March 31, 2027.
2. A copy of this resolution shall be available for public inspection at the offices of the RVRSA at 99 Greenbank Road, Township of Parsippany-Troy Hills, Morris County, New Jersey. Notice of Contract Award shall be published as required by law.
3. This Resolution shall take effect as provided by law.
