

**RESOLUTION AUTHORIZING AMENDMENT TO CONTRACT FOR
PROFESSIONAL SERVICES FOR MEDICAL SERVICES**

WHEREAS, by Resolution 26-002, adopted on January 8, 2026, the Rockaway Valley Regional Sewerage Authority (RVRSA) authorized the execution of a Contract with Atlantic Health Chilton Medical, for medical services in an amount not to exceed \$9,000.00; and

WHEREAS, medical services will no longer be available at the Atlantic Health Chilton Medical Center; and

WHEREAS, medical services will now be available through Atlantic Health Urgent Care Physicians of New Jersey, LLC; and

WHEREAS, the Authority desires to amend the Contract with Atlantic Health Chilton Medical to reflect the change to Urgent Care Physicians of New Jersey LLC; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40:11-1 et seq.) authorizes contracts for the provision of "Professional Services," which may be awarded without public advertising and competitive bidding therefore, provided a brief notice of the nature, duration, service and amount of contract is published, and that the Resolution and contract are kept on file and available for public inspection.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

1. Subject to receipt of all relevant political disclosure documentation required by N.J.S.A. 19:44A-20.4 et seq., the Executive Director is hereby authorized to execute an amendment to the professional services agreement between Atlantic Health Chilton Medical and the Rockaway Valley Regional Sewerage Authority for the provision of medical services to reflect the change to Urgent Care Physicians of New Jersey, LLC.
2. This agreement is awarded based on a non-fair and open process and is awarded without competitive bidding as a "Professional Service" under the provisions of the Local Public Contracts Law, N.J.S.A. 40:11-5 and the contract for said services will not allow political contributions pursuant to the applicable provisions of N.J.S.A. 19:44A-20 et seq.
3. A notice of contract award shall be published in the official newspaper, stating the nature, duration, service and amount of the contract, and that the Resolution and contract are on file and available for public inspection at the RVRSA.

4. This Resolution shall take effect immediately.
