

**RESOLUTION AUTHORIZING 1st AMENDMENT TO DESIGN PHASE SERVICES
AND RESIDENT PROJECT REPRESENTATIVE PROFESSIONAL SERVICES
CONTRACT WITH ONE WATER CONSULTING, LLC, FOR FURNISHING AND
INSTALLATION OF NEW EFFLUENT METER PROJECT – CONTRACT 51**

WHEREAS, by Resolution 24-074, adopted on August 8, 2024, RVRSA authorized One Water Consulting, LLC, having an office at Village Offices at Montgomery, 1378 Route 206, Suite 202, Skillman, New Jersey 08558 to undertake such services as set forth in One Water Consulting LLC, proposal dated July 19, 2024, in an amount not to exceed \$87,600.00 without prior authorization; and

WHEREAS, the RVRSA has received a proposal from James F. Cosgrove, Jr., P.E. President, and Brian J. Friedlich, P.E. Managing Engineer, One Water Consulting, LLC, dated June 24, 2026, attached hereto, for additional design, bidding and construction phase services as set forth therein; and

WHEREAS, the RVRSA desires to authorize One Water Consulting, LLC, to undertake additional services for additional design, bidding and construction phase services as set forth in the proposal for the same, dated June 24, 2026, attached hereto and made a part hereof, in an amount not to exceed 38,400.00 for a new total contract amount of \$126,000.00;

WHEREAS, the necessary additional funds are available in capital budget line item 01-853-022; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40:11-1 et seq.) authorizes contracts for the provision of “Professional Services,” which may be awarded without public advertising and competitive bidding, provided a brief notice of the nature, duration, service and amount of contract is published, and that the Resolution and contract are kept on file and

available for public inspection.

NOW, THEREFORE, BE IT RESOLVED by the Rockaway Valley Regional Sewerage Authority as follows:

1. The Rockaway Valley Regional Sewerage Authority recognizes that One Water Consulting, LLC has an established reputation in the fields of environmental and water science, engineering, wastewater facility operations and compliance, and that they possess specialized abilities and resources to provide the services necessary to meet the Authority's needs.
2. The Executive Director is authorized and directed to execute a 1st Amendment to the professional service contract between RVRSA and One Water Consulting, LLC, having an office at Village Offices at Montgomery, 1378 Route 206, Suite 202, Skillman, New Jersey, so as to authorize the expenditure of an additional not to exceed amount of \$38,400.00, to be paid on an hourly, cost reimbursable basis in accordance with the attached proposal dated June 24, 2026 for a new total contract amount of \$126,000.00.
3. All other provisions of the contract with One Water Consulting, LLC, shall remain in effect.
4. The foregoing services are "professional" services as defined in N.J.S.A. 40A:11-2(6) which are permitted to be contracted without public bidding as set forth in N.J.S.A. 40A:11-5(1) (a) and as a "non-fair and open" contract pursuant to the provisions of N.J.S.A. 19:44A-20-5.
5. A copy of this resolution shall be available for public inspection at the offices of the RVRSA.
6. Notice of Contract Award shall be published as required by law.
7. This Resolution shall take effect as provided by law.
