APPENDIX IV

Rate Schedule

General

The Authority hereby establishes a system of rates and charges for Application Fees, Technical Review Fees, Inspection Fees Rates and Charges required to defray costs incurred or to be incurred in conjunction with various applications made to the Authority for sanitary sewer extensions and other services described below.

Request for Environmentally Sensitive Area (ESA)

Grant Condition Waiver Applications.

Technical and administrative review and processing of ESA grant condition waiver requests shall be accompanied by a non-refundable application fee of \$600.00.

Time Extension Requests for Allocation of Gallonage.

Applications for administrative review and processing of time extensions within the various gallonage categories shall be accompanied by a non-refundable application fee of \$250.00.

Sanitary Sewer Extensions

A. Endorsement of NJDEP CP-1 Application.

The Application Fee for the administrative and technical review of Sanitary Sewer Extensions shall be based upon the number of dwelling units (DUs) for residential sewer extensions or the number of equivalent dwelling units (EDUs) for non residential Sewer extensions. For the purposes of calculating fees under the section, the term EDU's also applies to DUs.

2 EDUs or less	\$450
3 - 11 EDUs	\$450 plus \$30 per EDU above 2 EDUs
11 - 50 EDUs	\$700 plus \$8 per EDU above 10 EDUs
51 EDUs or More	\$1000 plus \$6 per EDU above 50 EDUs

B. Feasibility of Sewer Service

- (1) Application Fee- The application fee for requests for investigations regarding the feasibility of sanitary sewer service for existing or proposed development shall be calculated based upon the number of dwelling units (DUs) for residential sewer extensions or the number of equivalent dwelling units (EDU) for non residential sewer extensions for the purposes of calculating fees under this section, the term EDUs also applies to DUs.

2 EDUs or less	\$450
3 - 11 EDUs	\$450 plus \$30 per EDU above 2 EDUs
11 - 50 EDUs	\$700 plus \$8 per EDU above 10 EDUs
51 EDUs or More	\$1000 plus \$6 per EDU above 50 EDUs

- (2) Technical Review Fee - If required by the Authority following a preliminary review of the application for feasibility of sewer service, an escrow deposit shall be submitted to the Authority. The escrow amount shall be comprised of the initial application fee plus an additional amount to be determined by the Authority. The amount will be predicated upon the scope and complexity of the project proposed for review.

RVRSA Sewer Connection Permit and Inspection Fees

Applications for Sewer Connection Permits shall be accompanied by a fee calculated in accordance with the following schedule:

1. Residential Connections Permit Fee:

Upon the submission of a permit application, a fee of \$30.00 shall be paid for each "dwelling unit". For the purposes of this section a "dwelling unit" means unit intended to be a residence for one or more persons and containing therein cooking, sleeping and bathroom facilities.

2. Non-Residential Connection Permit Fee.

Upon the submission of a Permit Application, a fee of \$30.00 shall be paid for each "equivalent dwelling unit."

3. Residential/Non-Residential Connection Inspection Fee.

Upon the submission of a Permit Application, a fee of \$30 per sewer connection shall be paid. An additional fee of \$15 will be charged if the applicant, after arranging for an inspection at a specific time, is not ready for the inspection. This additional fee will be charged for each scheduled inspection wherein the applicant is not ready.

Inspection of Sewer Extension

Applications for sewer extension inspections shall be accompanied by a fee of \$20 per proposed test section. The application fee shall be calculated on the basis of the entire sewer extension project. If additional test sections are required, additional RVRSA inspection time shall be charged at \$20 per additional section.

OTHER SUBMITTALS

A minimum non refundable fee of \$200 shall be paid upon the submission of an application for reviews, endorsements or other work not covered by the Authority's Rate Schedule. Depending upon the nature of the application, escrow deposits shall be determined by the Authority's consulting engineer or Executive Director prior to technical review of the application.

MISCELLANEOUS CHARGES

2. Other Services

Charges for other services such as delivery, postage and other direct expenses incurred by RVRSA shall be calculated at actual cost.

ADMINISTRATION OF ESCROW DEPOSITS AND APPLICATION FEES

- Applications to RVRSA shall be submitted in triplicate on forms provided and accompanied by the Application Fee required by the RVRSA Rate Schedules.
- Application Fees are non-refundable.
- Escrow deposits for Technical Review Fees, Inspection Fees, or other purposes shall continue to be the property of the applicant and shall be held by RVRSA in trust on behalf of the applicant in a separate, interest bearing account for that purpose.
- RVRSA shall notify the applicant in writing of the name and address of the depository of the funds held in escrow, the amount and date of the deposit, and the escrow account number.
- Costs incurred by RVRSA shall be charged against the applicant's escrow account(s) for the specific services rendered for each escrow account established.

6. In the event that an applicant's escrow deposit shall be depleted or, in the opinion of the Authority's Executive Director, will be depleted prior to the completion of the work, RVRSA shall notify the applicant in writing of the deficiency or estimated deficiency amount. The applicant shall provide the additional escrow deposit to RVRSA within 15 days of said notice.

7. Escrow deposits, including interest earned thereon remaining upon completion of the work, shall be refunded to the applicant within 30 days of completion as certified by action of RVRSA or by notice from the Authority's Executive Director and/or consulting engineer.

WAIVER PROVISIONS

If by reason of undue hardship or exceptional unforeseen circumstances or where the imposition of charges is impracticable, the Authority may by Resolution in special cases and for special reasons set forth therein, modify these rates at its discretion.

CONTRACT FEES AND CHARGES

The rates, fees, and charges set forth herein shall not alter or modify any rates, fees, or charges provided by or to be provided by contract between the RVRSA and others.
